

The Papua New Guinea Immigration and Citizenship Services Authority is extending a Special Exemption – Designated Events Visa (SE-DEV) upon arrival to all eligible international delegates invited for the IMAAC 2019. The SE-DEV will be issued at **NO COST** and will be granted for passport holders of the following eligible countries/nationalities:

NOTE: For delegates coming from countries not listed above, an “uplift letter” will be provided and must be presented to the immigration at their port of origin to enable them to board the aircraft. This document must again be presented at the PNG immigration upon arrival at the Port Moresby International Airport for issuance of visa on arrival. Copy of the delegates’ passport must be provided in advance to the Protocol Team of the PNG Judiciary so the “uplift letter” could be issued and coordinated with the PNG immigration.

Delegates transiting through another country must make their own arrangement to secure appropriate entry visa in the countries they are transiting.
